

## **Ontario *OUT of DOORS* 50th Anniversary Giveaway Contest RULES AND REGULATIONS**

1. Contest starts at 2:00 pm (ET) on February 9, 2018 and continues until 10:00 am (ET) on December 4, 2018 the Contest Closing Date. No purchase necessary. Limit: unlimited entries per person. To enter, go to [www.oodmag.com/contests/](http://www.oodmag.com/contests/), click 50th Anniversary Giveaway Contest, complete the form in full and press the submit button by the Contest Closing Date.
  - (a) A random draw selecting 50 entries will be made by a representative of **Ontario *OUT of DOORS (OOD)*** from all entries received as of December 4, 2018 at approximately 10:00 am on December 4, 2018. The winners will be contacted by e-mail.
  - (b) If a selected entrant cannot be reached on or before 3:00PM December 7, 2018; incorrectly answers the skill- testing question; declines the prize; or fails to return a Release of Liability as specified below, another entrant will be selected.
